

Conform cerintelor Regulamentului (UE) 2016/679 pentru protectia persoanelor cu privire la prelucrarea datelor cu caracter personal si libera circulatie a acestor date, modificata si completata si ale Legii nr. 506/2004 privind prelucrarea datelor cu caracter personal si protectia vietii private in sectorul comunicatiilor electronice SC TRIPLAST SRL are obligatia de a administra in conditii de siguranta si numai pentru scopurile specificate, datele personale pe care ni le furnizati despre dumneavoastra, un membru al familiei dumneavoastra ori o alta persoana prin completarea urmatoarelor campuri din factura fiscală: nume complet, companie (societatea la care sunteți angajat), seria si numarul cartii de identitate, CNP-ul, adresa – dupa caz.

Scopul colectarii datelor este indeplinirea formalitatilor emiterii documentelor financiar-contabile aferente tranzactiilor pe care le derulati cu compania TRIPLAST si protectiei patrimoniului companiei impotriva sustragerii frauduloase de catre persoane tertе, fizice, sau juridice, interne, sau internationale, de orice fel.

Nu sunteți obligat(a) sa furnizati datele. Refuzul dumneavoastra determina insa imposibilitatea derularii activitatilor pentru scopurile mai sus indicate.

Informatiile inregistrate sunt destinate utilizarii exclusiv de catre TRIPLAST direct, in calitate de operator.

Conform Regulamentului (UE) 2016/679, beneficiati de dreptul de acces, de interventie asupra datelor, dreptul de a nu fi supus unei decizii individuale si dreptul de a va adresa justitiei. Totodata, aveti dreptul sa va opuneti prelucrarii datelor personale care va privesc si sa solicitati stergerea datelor*. Pentru exercitarea acestor drepturi, va puteti adresa cu o cerere scrisa, dataata si semnata la adresa de e-mail: office@triplast.ro. De asemenea, va este recunoscut dreptul de a va adresa justitiei.

Pentru derularea activitatilor ce reprezinta scopurile colectarii informatiilor mentionate mai sus, datele dumneavoastra personale NU vor fi transferate catre alte entitati, cu nici un scop.

Daca unele din datele despre dumneavoastra sunt incorecte, va rugam sa ne informati cat mai curand posibil.

Observatie:

- orice persoana are dreptul de a se opune, pentru motive legitime, la prelucrarea datelor ce o privesc. Acest drept de opozitie poate fi exclus pentru anumite prelucrari prevazute de lege (de ex.: prelucrari efectuate de serviciile financiare si fiscale, de politie, justitie, securitate sociala). Prin urmare, aceasta mentiune nu poate figura daca prelucrarea are un caracter obligatoriu;
- orice persoana are, de asemenea, dreptul de a se opune, in mod gratuit si fara nici o justificare, la prelucrarea datelor sale personale in scopuri de marketing direct.
- opunerea Dumneavoastra impotriva colectarii si prelucrarii datelor cu caracter personal atrage dupa sine imposibilitatea incredintarii inspre livrare a bunurilor care fac obiectul facturii/avizului/notei de transfer pentru care v-ati prezentat la sediul SC TRIPLAST SRL

According to Regulation (EU) 2016/679 for personal protection regarding processing of personal data and free circulation of such, modified and fulfilled, based also on Law no.506/2004 regarding processing of personal data and protection of private life within electronic communications, SC TRIPLAST SRL has the duty to handle in safe conditions the data you provide about yourselves, a member of your family or any other person in secure conditions and only for the specified reasons, for completion of fields on Invoices, such as full name (company that you are employed of), serial number and number of ID, personal identification number, address – as required.

The reason to collect personal data is the fulfillment of requirements for issuing of financial/accounting documents linked to transactions you engage in with TRIPLAST and the protection of the company's belongings, against theft by physical and legal entities, internal or international of nature, or of any kind.

You are not bindingly required to supply the data depicted above. Your refusal shall indeed result in impossibility of fulfilling the activities that you were dispatched for.

The information gathered is only designated to be used by TRIPLAST directly, as operator.

According to Regulation (EU) 2016/679, you have the right to intervene above the registered data, the right not to be subjected to individual decision, and the right to address the court. Simultaneously, you have the right to oppose personal data processing and to request deletion of all data. To exercise this right, you are required to hand in written request, dated and signed, to the address office@triplast.ro. Similarly, your rights to justice are observed at any times.

None of your personal data gathered and processed during fulfillment of legal requirement and objects of this disclaimer, are transferred to other entities, under no conditions.

If any of data is mistaken, please let us now.

Note:

- any person has the right to oppose – for justified reasons – processing of personal data. This right of opposition might be revoked for only some of processing types, as depicted by law (e.g. financial and fiscal law, policing, justice, and social security reasons). Therefore, this exemption cannot take place for said mandatory reasons.
- any person has the right to oppose free of charge without any justification processing of his/her personal data for marketing purposes.
- your opposition against personal data collection and processing shall draw the impossibility of handover of goods that are depicted in Invoices, Delivery notes, or Transfer notes of any kind originated by TRIPLAST SRL to third parties, for fulfillment of which you have been delegated to.
